- 2. Which are the most important reasons for social vulnerability?
- 3. Please, describe and interpret the terms race, racism, racist ideology and racist behavior!
- 4. Please, analyze the mechanisms of ethnic hatred and the social conflicts resulting from them!
- 5. Please, describe the most important factors that endanger migrants on the road to their countries of aim.
- 6. Please, define "trafficking in humans" as a crime and depicts its female victims as well as the methods of their protection.
- 7. Please, list the most important shapes of social discrimination and the forms and possibilities of combating them.

- 6. What is the role of NGOs in the humanitarian assistance regime? Explain their evolution and their characteristics.
- 7. Please elaborate on the evolution of the Red Cross family. How was it created, what was its role since then, what are its institutions now?
- 8. How did World War II and the Cold War influence the evolution of the humanitarian system? What legal norms and institutions were created in response to the WWII?
- 9. Please select a humanitarian emergency of the 21st century. (You can select one from what we learnt together, but also another one.) Please explain shortly its social, political and economic background. Try to analyse it shortly from a humanitarian point of view: what were the humanitarian characteristics of this emergency? How was it special? Were there lessons learnt for the humanitarian community?

10. What standards are commonly used in humanitarian assistance? Please explain why and how these were created, what are its advantages and disadvantages?
